The Guy Solley and Dafford Brewster Collection consists of a variety of materials relating to the steel industry, steel unions and their activities. A large portion of the collection consists of grievances filed by employees against their employers. Written agreements between employees and their employers also make up a large portion of the collection. Various convention materials, manuals and reports, employee benefits pamphlets and information all related to the steel industry are included in the collection as well as a variety of miscellaneous publications, pamphlets, photographs, and artifacts.
